REPORT

“Zero Waste Strategy for Good Environmental Status” Project 4th (Final) Congress/Workshop online event hosted by Tekirdağ Namik Kemal University (TNKU) was held on the 21st January 2021.

The Congress/Workshop consisted of four sessions;

Session 1: Welcome speeches and press conference

Session 2: ZEWSGES Project General Project Overview

Session 3: ZEWSGES Project Ecosystem Education Programme & Marine Litter Overview

Session 4: Project Coordination Meeting: ZEWSGES Project Closure

The sessions were moderated by Prof. Dr. Fatih KONUKCU

Session 1: Welcome speeches and press conference

In the first Session, representatives of the institutions, National Authority and JTS, namely, **Mr. Giorgi MESKHIDZE**, the President of International Association CIVITAS Georgica- GEORGIA, **Ms. Sonya ENILOVA**, Representative of TDCNM (Tourism Development Council in Nessebar Municipality BULGARIA), **Mr. Nykyta KARPENKO**, President of UKRMEPA (Ukrainian Marine Environment Protection Association-UKRAINE), **Prof. Dr. Bulent EKER**, Vice Rector of TNKU, **Mr. Serkan BOZKURT**, Republic of Turkey Ministry of Foreign Affairs-EU Affairs Expert and **Mrs Georgiana Bratu**, JTS-Romania made short speeches. **A total of 44 people** participated in the online event. A press release was disseminated to the media in the break followinthe first session.



Session 2: ZEWSGES Project General Project Overview

In the second session, the General Project Coordinator **Mr Ali Sirri OREN** (TNKU-TURKEY) and **Ms. Sonya ENILOVA**, Project Coordinator - TDCNM, Bulgaria, **Nykyta KARPENKO**, Project Coordinator - UKRMEPA, Ukraine, **Mr. Mamuka GVILAVA**, Project Coordinator - CIVITAS Georgica, Georgia made presentations on the general achievements of the ZEWSGES project in their country. In conclusion, it is understood that the targets of the project have been achieved in all partner countries. **A total of 39 people** participated in the second session. What Project coordinators presented were combined with the presentation on EEP an ME Coordinators in session 3.

Session 3: ZEWSGES Project Ecosystem Education Programme (EEP) & Marine Litter (ML) Overview

In this session, All details of EEP and ML activities were discussed by EEP and Marine Environment (ME) Coordinators. A total of 38 people participated in the third session

Prof. Dr. Fatih KONUKCU (EEP in TNKU) summarized the activities carried out within the scope of the EEP as follows: Within the scope of the project, a Multimedia Ecosystem Education Set was developed for students aged 7-16 in four languages (Turkish, Bulgarian, Ukrainian and Georgian). The training set consists of 20 short ecosystem training videos (40 minutes in total), an online game, posters, brochures, training guidelines and Ecosystem Awareness Questionnaire. A total of 2.228 students and 128 teachers were trained and awareness was raised on the ecosystem. This activity was carried out with the Protocol signed with TNKU and Tekirdağ Provincial Directorate of National Education. In Tekirdağ, 600 kg of litter was collected in beach clean up campaign and 480 students, 50 teachers, 15 NGOs and 12 local media participated to draw attention to marine pollution. All data on EEP was integrated in an "interactive integrated ecosystem database". It was seen from the Ecosystem Awareness Questionnaire that students and teachers filled out before and after the training, that the ecosystem awareness level increased from 40% to 85%.

Prof. Dr. Lokman Hakan TECER (MEC of NKU) summarized the activities regarding Marine Litter as follows: **Marine/Beach Litter Monitoring Method and Program** was developed in line with the EU legislation. **Marine/Beach Litter Monitoring program** was conducted **8 times** (4 times a year, once every season). The seasonal trend, classification and source of litter were determined. Strategies for prevention were discussed. **Fishing for Litter Campaign** was carried out. More than **150 fishermen** and more than **40 boats**, protocols, researchers, students, NGOs and local people participated in Fishing for Litter Campaign in Kıyıköy, Kırklareli. The divers collected more than 1000 kg litter from the bottom of the sea near the beach and drew attention to sea pollution. The data obtained as a result of ML monitoring were recorded in the integrated database (Marine Litter Watch).

Mr. Mykyta KARPENKO, ZEWSGES Project Coordinator in Ukraine detailed the achievements of EEP and ML as follows: Materials for EEP were collected, 20 educational videos were edited, 41 teachers (out of 30 planned) were trained and 1541 students (out of 1500 planned) were trained. In Fishing for Litter activity was realized by the 102 local fishermen. In Beach Clean up Campaign, 117 people (including 88 pupils and teachers, 8 fishermen, 21 members of the project - representatives of the participating teams from Turkey, Georgia, Bulgaria and Ukraine) were involved. Totally, 7 marine litter monitorings were

realized. **333 people** took part including pupils and teachers (project plan is 500 in Ukraine, implementation 65 %- reason Covid-19). It was collected at least 3,718 tons of litter from the beaches (project plan is 0,5 tons in Ukraine, achievements 743%).

Mrs. Fani SEMERDZHIEVA, ZEWSGES MEC of TDNM in Bulgaria detailed the achievements of EEP and ML as follows: **5 Beach Clean up Campaigns** were realized with **292 people** and **600 kg litter** was collected. In **4 Fishing for Litter campaigns**, **60 participants** collected **800 kg litter**. As for the EEP, **520 students** and **55 teachers** were trained in **5 schools**.

Mrs. Tamar TSAMALASHVILI, ZEWSGES ME Coordinator of Civitas Georgica presented Monitoring Marine Litter on Land and Mr. Mamuka GVILAVA, Project Coordinator of Civitas Georgica in GEORGIA presented Fishing for Litter in the sea and EEP as follows: **8 Beach Monitoring Activity** were realized. Fishing for Litter activity was completed. Hundreds of students and 10 teachers in 4 schools were trained under the scope of EEP.
